Choose the **Social & Behavioral Investigators** human subjects research module.
- 4. The course may take a few hours to complete but can be done over a period of time. When you complete the course, CITI will e-mail your completion record to the CMU IRB.
- 5. From the CITI main menu, you can also print a copy of the completion report for this course. *Turn in a printed copy of your completion report with this homework.*

If you already have an active certificate of completion from a course on ethical treatment of human subjects in research, that you took earlier, you can just attach a copy of that older certificate with your hw, without taking the CITI training course.

(You can use the certificate of completion for several years, in any future human subjects research approval process you may be involved in.)

Exercises to Turn In (there are 4 excercises):

- 1. The Health Behavior in School-Age Children Study (HBSC) is an international survey conducted under the auspices of the World Health Organization.
 - (a) Find the home page for this survey project on the web, and fill out, as completely as possible, a table like Tables 1.1–1.6 of the Groves text, for the the International Report "2001/02 International Report: Young People's Health in Context". You may need to use links from the homepage to get the information you need.
 - (b) Please comment on any items in your table that would make it difficult to understand or believe the results of the survey (e.g. you couldn't get the information, or the information you got worries you in some way). If you are happy with all the information in your table, just say that.
- 2. For several years, the American Automobile Association (AAA) has conducted a survey called the Traffic Safety Culture Index. The 2010 report (as well as reports from earlier years) can be found at http://www.aaafoundation.org/reports. Re-do question #1 (both parts!) for the AAA Traffic Safety Culture Index survey.
